



Figure 1. Count and Rate of Incident Injuries\*, Ft. Shafter & Army, AUG 2014-JAN 2016





**Figure 2. Rate of Incident Eye and Hearing Injuries\*, Ft. Shafter, AUG 2014-JAN 2016**




**Figure 3. Rate of Incident Upper and Lower Extremity Injuries\*, Ft. Shafter, AUG 2014-JAN 2016**





**Figure 6. Percentage of Injured Service Members by Number of Medical Encounters - Ft. Shafter & Army, December 2015**


