Biographical Note: Donald Gene Wright was born in Springfield, MO on February 3, 1929, to Leonard Emmet “Ted” Wright and Lelia Mae Wallace Wright. In 1950, he married Wanda Lynn Payton, and the following year graduated Drury College in Springfield with a B.S. in Chemistry. He subsequently joined the Air Force, where he became a medical technician and pilot, logging over 3,300 hours of B-52 time from 1958-1965. He went on to earn his M.D. from The University of Missouri in Columbia in 1969, and finished his internship and residency at The University of Missouri, Columbia, and Wesley Medical Center in Wichita, Kansas. After completing his residency, Wright was a civilian for a little over a year before returning to active duty in January 1975, advancing to Lieutenant Colonel. He completed his forensic residency at AFIP in 1984, his training in Baltimore and Washington DC with their respective medical examiner’s offices, and became well-known as a specialist in the investigation of aircraft accidents and mass disasters. After retiring in 1990, he served for several years as Deputy Chief Medical Examiner for the State of Maryland.

Series/Scope and Content Note: The eleven series in this collection are organized by subject and the type of material donated. The material is organized chronologically or preserved in its original order wherever possible. The bulk of the collection consists of over 15,000 slides from Dr. Wright’s collection of forensic pathology cases. Manuscripts in the collection include military and professional service records, administrative material, lectures, articles, and material related to Wright’s investigations and research, including some photographs. Oversized items include certificates and flight records. A small number of multimedia items include VHS tapes, audiocassettes, and floppy disks.

SERIES 001: MILITARY AND PROFESSIONAL BACKGROUND

This series includes materials from Dr. Wright’s military service and his work as a forensic pathologist. Items include a CV documenting the major positions and accomplishments of Dr. Wright, diplomas and transcripts, military orders, and personnel files.



SERIES 002: ADMINISTRATIVE MATERIAL

This series includes material primarily from Dr. Wright's medical education and subsequent work at the Armed Forces Institute of Pathology. Items include reports, memoranda, evaluation forms, manuals, appendices, performance standards, and examination materials.

SERIES 003: LECTURES AND PRESENTATIONS

This series consists of materials from eight lectures and presentations delivered by Dr. Wright on a variety of pathology topics between 1970 and 1989, along with a forensic pathology presentation by John M. Smialek.

SERIES 004: ARTICLES AND REPRINTS

This series includes primarily secondary literature collected by Dr. Wright, and includes twenty-four articles on a variety of topics related to medical subjects, with a focus on forensic pathology.

SERIES 005: INVESTIGATIONS AND SUPPLEMENTAL RESEARCH

This series includes background research materials on a variety of subjects related to forensic pathology, case materials from a limited number of investigations, and documents used in the course of Dr. Wright's work as a forensic pathologist. Additionally, documents related to special projects include the following subjects: arthritis, medicolegal decision-making processes, and the medical examiner and coroner identification system.

SERIES 006: SUICIDE INVESTIGATION AND SUPPLEMENTAL RESEARCH

This series includes research materials and publications from a project on suicides conducted by Dr. Wright and colleagues in the late 1980s. Included are hundreds of suicide notes collected from cases, study forms, and presentation materials.

SERIES 007: CLIPPINGS

This series includes newspaper clippings from a variety of cases, some investigated by Dr. Wright, including aircraft accidents and bombings.

SERIES 008: PHOTOGRAPHS AND NEGATIVES

This series includes photographs and negatives from ten of the cases investigated by Dr. Wright, along with a series on the subject of bone lesions due to abuse.

SERIES 009: SLIDES

This series includes over 15,000 slides from Dr. Wright's collection. These slides, originally stored in notebooks, were not organized by subject and included brief descriptions of cases involved in some cases or simple titles. The slides have been organized into twenty-five categories, by subject or general type of case involved.



SERIES 010: CERTIFICATES, LETTERS OF APPRECIATION, PHOTOGRAPHS AND OVERSIZED MATERIAL

This series consists of oversized material including flight records over the course of Dr. Wright’s career, along with certificates, awards, letters of appreciation, and a handful of photographs.

This series includes VHS tapes, audiocassettes, and floppy disks covering a range of forensic pathology topics.
